SUPERINTENDENT GOALS

On the motion of Ms. Lindsey, seconded by Mr. Hommrich, the Board approved the following goals for William P. Stropkaj, Superintendent as per the Superintendent's Contract 2017/2022:

- 1. By May 1, 2019, the administrative staff will be engaged in creating the foundation for a new strategic plan that is based upon meeting the academic, social, and emotional needs of all learners within the District. This will be accomplished by a book study of *Inevitable: Mass Customized Learning in the Age of Empowerment* by Charles Schwahn and Beatrice McGarvey. The structure of the new strategic plan will be developed through this process and will serve as a guide for the Strategic Plan Committee. The administrative staff will periodically reflect on the process and structure and will provide feedback on the development of the new strategic plan.
- 2. By May 1, 2019, all curriculum leaders and department liaisons will be engaged in a book study of *Total Leader 2.0: Leading in the Age of Empowerment* by Charles Schwahn and William Spady to create a professional leadership vocabulary and to foster professional dialogue that will promote the development of a new strategic plan that is focused on the meeting the academic, social, and emotional needs of all learners in the District. Collaborating with the administrative staff, the curriculum leaders and

department liaisons work will support the structure of the new strategic plan process. The curriculum leaders and department liaisons will reflect on the process of developing their leadership skills along with providing feedback on the development of the new strategic plan.

- 3. By May 1, 2019, the District will begin the development of a new strategic plan that is based upon meeting the academic social and emotional needs of all learners within the District. This process will include students, parents, community members, business leaders, staff, faculty, administration, and Board members. Interim summary reports will be provided to the Board during the process.
- 4. By March 1, 2019, a survey will be developed that will gather input from former Keystone Oaks graduates regarding their preparedness for life beyond Keystone Oaks. This survey will be distributed to all former graduates of the Classes of 2018 and 2017. Data from the survey will be shared with the Strategic Plan Committee so as to provide information that guide discussion and decisions for the new strategic plan.
- 5. By February 1, 2019, learning experiences, which offer students in Kindergarten through grade 12 opportunities to grow academically, socially, and emotionally, will be developed to meet the personal needs of students. These programs will be offered during the summer of 2019.
