	<p style="text-align: center;"><b>POLICY NO. 810.1</b> <b>SCHOOL BUS DRIVERS AND SCHOOL COMMERCIAL VEHICLE DRIVERS</b></p> <p><b>Section 1</b>    <u><b>Purpose</b></u></p> <p>The Board recognizes that an employee must be fit to operate a school bus and commercial motor vehicle to ensure the health and safety of students being transported. The Board also recognizes that an employee impaired by drugs or alcohol who operates district vehicles or transports students poses significant risks to the safety of students and others.</p> <p><b>Section 2</b>    <u><b>Definitions</b></u></p> <p>The following words and phrases, when used in this policy, shall have the meaning given to them in this section:</p> <p>A <b>covered driver</b> shall include any district employee who drives, operates or is in the actual physical control or movement of a school bus or a commercial motor vehicle owned, leased or operated by the School District. The term includes drivers and mechanics who operate such vehicles, including full-time, regularly employed individuals; leased drivers; and independent owner-operator contractors who are directly employed by or under lease to the district or who operate a bus or commercial motor vehicle owned or leased by the District.</p>	<p style="text-align: center;">49 CFR 382.107</p>

	<p style="text-align: center;"><b>POLICY NO. 810.1</b> <b>SCHOOL BUS DRIVERS AND SCHOOL COMMERCIAL VEHICLE DRIVERS</b></p> <p><b>Commercial motor vehicle</b> - a motor vehicle or combination of motor vehicles used in commerce to transport passengers or property if the vehicle:</p> <ol style="list-style-type: none"> <li>1. Has a gross combination weight rating or gross combination weight of 26,001 or more pounds, whichever is greater, inclusive of towed unit(s) with a gross vehicle weight rating or gross vehicle weight of more than 10,000 pounds, whichever is greater;</li> <li>2. Has a gross vehicle weight rating or gross vehicle weight of 26,001 or more pounds, whichever is greater;</li> <li>3. Is designed to transport sixteen (16) or more passengers, including the driver; or</li> <li>4. Is transporting hazardous materials and is required to be placarded.</li> </ol> <p><b>Driving</b> – operating a commercial motor vehicle or motor carrier vehicle on a highway, with the motor running, including while the commercial motor vehicle or motor carrier vehicle is temporarily stationary because of traffic, a traffic control device or other momentary delay. The term does not include operating a commercial motor vehicle or motor carrier vehicle with or without the motor running if the driver moved the vehicle to the side of or off of a highway and halted in a location where the vehicle can safely remain stationary.</p> <p><b>Electronic device</b> – an electronic device includes, but is not limited to, a cellular telephone, personal digital assistant, pager, computer or any other device used to input, write, send, receive or read text.</p> <p><b>Mobile telephone</b> – a mobile communication device which uses a commercial mobile radio service.</p> <p><b>Safety-sensitive functions</b> include all on-duty functions performed from the time a driver begins work or is required to be ready to work until s/he is relieved from work and all responsibility for performing work. The term includes, but is not limited to, short message service, emailing, instant messaging, a command or request to access an Internet web page, pressing more than a single button to initiate or terminate a voice communication using a mobile telephone or engaging in any other form of electronic text retrieval or entry, for present or future communication.</li> <li>2. The term does <u>not</u> include: <ol style="list-style-type: none"> <li>a) Inputting, selecting or reading information on a global positioning system or navigation system.</li> <li>b) Pressing a single button to initiate or terminate a voice communication using a mobile telephone.</li> <li>c) Using a device capable of performing multiple functions, including, but not limited to, fleet management systems, dispatching devices, citizens band radios and music players, for a purpose that is not prohibited by law.</li> </ol> </li> </ol>	<p>75 Pa. 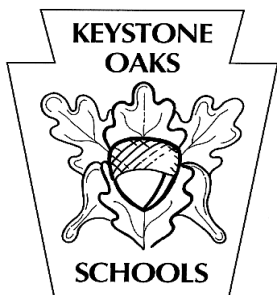
